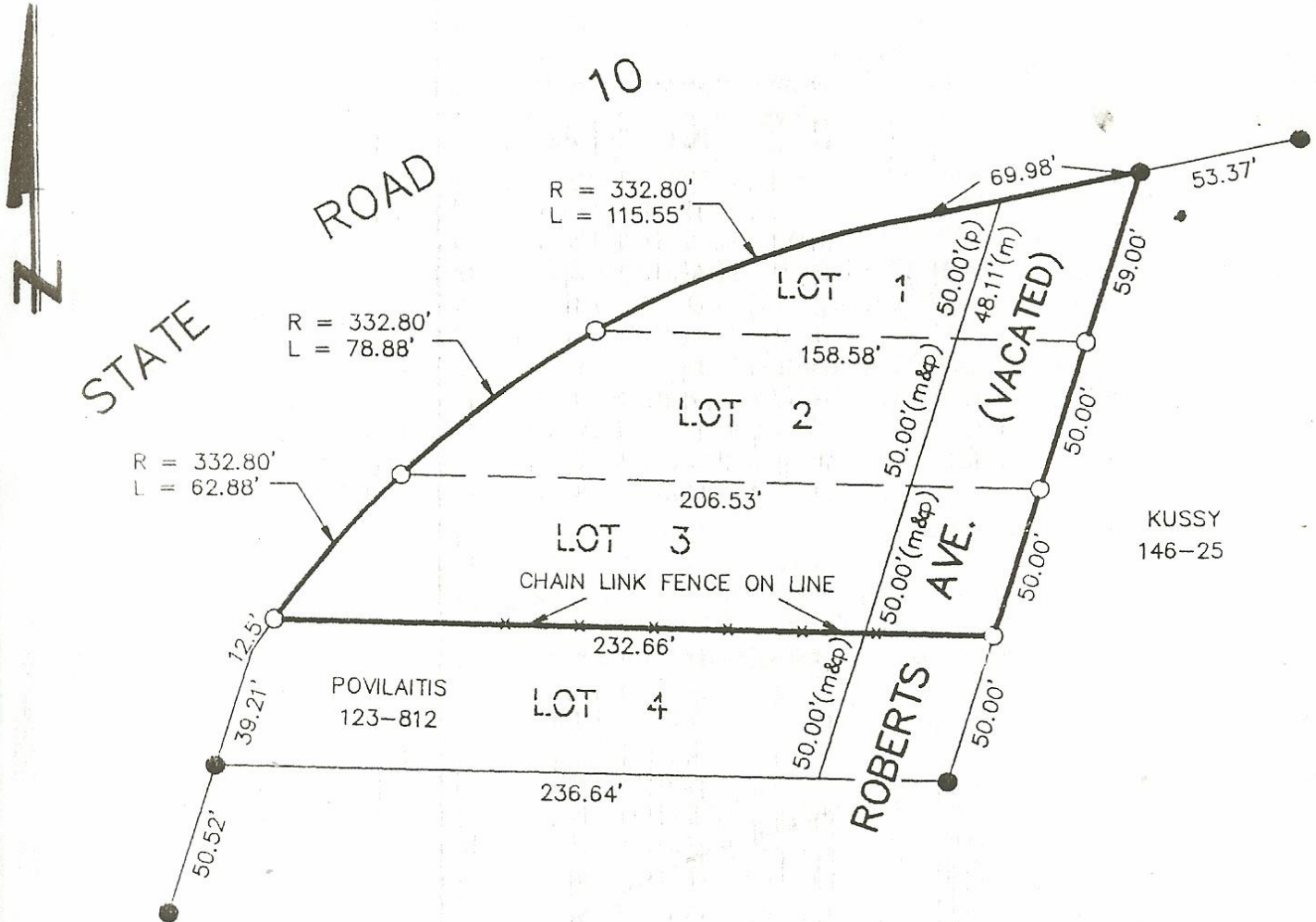


CERTIFICATE OF SURVEY

LEGAL DESCRIPTION

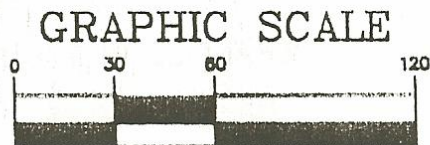
